RESOLUTION

ON ISSUING OF INTEGRAL PERMIT FOR COLLECTING AND TRANSPORTING OF NON-HAZARDOUS AND HAZARDOUS WASTE ON THE TERRITORY OF THE REPUBLIC OF SERBIA

Permit for collecting and transporting of non-hazardous and hazardous waste (specified in item 2.1.1) and hazardous waste (specified in item 2.1.2) on the territory of the Republic of Serbia, Reg. No. 009 has been issued to the operating company EKO METAL d.o.o. Vrdnik and the following has been established:

A. GENERAL DATA

1) General data about the permit

Permit for performing activities of collecting and transporting of non-hazardous waste (specified in item 2.1.1) and hazardous waste (specified in item 2.1.2) on the territory of the Republic of Serbia in accordance with the Law on waste management (Official Herald of RS, No. 36/09), has been issued to the operating company EKO METAL d.o.o Vrdnik.

2) General data about equipment and appliances

Operation company EKO METAL d.o.o. Vrdnik is completely equipped for performing activities of collecting and transporting of non-hazardous waste (specified in item 2.1.1) and hazardous waste (specified in item 2.1.2) on the territory of the Republic of Serbia.

B. ACTIVITIES INCLUDED IN THE APPLICATION AND EVALUATION OF APPLICATION

1.) Brief description of activities from the application

Operation company EKO METAL d.o.o. Vrdnik has been dealing with collecting and transporting of of non-hazardous waste (specified in item 2.1.1) and hazardous waste (specified in item 2.1.2) on the territory of the Republic of Serbia.

Non-hazardous waste is transported in the highway traffic observing the regulations on highway transportation. Every transport of related waste is supported by a Document on waste moving (Official Herald of RS, No. 72/09).

Transportation of hazardous waste is carried out by certified trucks for transportation of hazardous waste (ADR). Only persons that possess ADR Certificate on professional qualification - driver of trucks that transport hazardous material, may drive such trucks. For the purpose of traffic safety the equipment must be packed and stacked on the truck according to regulations and safety. Heavy machines or appliances of a certain type of waste are packed on the truck without packing material for specific purposes. They are fixed and tied in order to prevent them from moving during transportation. Light equipment and bulk freight of a certain type of waste is packed adequately and put on trucks.

The following must be considered in the procedure of preparation for issuance of Permit for collecting and transporting of mentioned waste on the territory of the Republic of Serbia: Application of the operating company including all data, registration of company for carrying out of necessary activities, memorandum of association of the company, data about waste, documentation about equipment and appliances for collecting and transporting of waste, including Certificates on safety of vehicles for transportation of certain hazardous goods in the highway transportation with supporting documents, ADR Certificates of professional qualifications of drivers for vehicles that transport dangerous substances, Certificates on passed qualification examinations for persons who handle dangerous substances, or are involved in preparation of transportation, load, reload or unload of dangerous substances, evidence on paid administrative fees.
